78TH ANNUALMEETING RECAP

hanks to all our members who were able to attend our 78th Annual Meeting in Cheyenne Wells. I know this is a busy time of year for our membership and I'm grateful for the members who attended the meeting.

K.C. Electric Association is served by a nine-member board of directors which is elected from the membership. The nine board of directors consist of five representatives from Kit Carson County, three representatives from Cheyenne County, and one representative from Lincoln County. Each year during the annual meeting three directors are elected to serve a three-year term. During this year's annual meeting, the membership elected two directors from Kit Carson County and one director from Cheyenne County.

Incumbent Cheyenne County director Jerry Allen ran unopposed and was elected to serve a three-year term. Incumbent director Terry Tagtmeyer and Justin Rueb were elected to represent Kit Carson County for the next three years.

Instead of our typical board president and general manager speeches, this year we had a panel discussion, an industry update, and a presentation on our new bill design.

Board President Penny moderated the panel discussion which included Operations Manager Darren Fox and Cheyenne Wells Area Foreman Judge Unruh. Most of their discussion focused on how K.C. crews respond to outages and how the restoration process works so that power can safely be restored as quickly as possible.

I gave an industry update that focused on Colorado's transition to renewable energy. And I discussed the Tri-State Generation and Transmission and Xcel energy transmission line construction occurring in our service territory, and discussed the difference between demand and energy and how it impacts our power bill.

To conclude this portion of the meeting, K.C. Electric Chief Financial Officer Bo Randolph presented the sleek new bill design that office staff have been working on



Ensuring your thermostat is free from these types of interferences optimizes energy efficiency, improves indoor comfort, and reduces wear and tear on your cooling/heating system.




