# THE COOPERATIVE ADVANTAGE

MVEA Launches On-Bill Repayment Program

V e often talk about the cooperative advantage of membership and our unique business model that puts members first. This month, as we join electric cooperatives across the U.S. in celebrating National Co-op Month, I am excited to share a new program that truly exemplifies the cooperative spirit and Mountain View Electric Association's commitment to providing safe, reliable, affordable, and responsible energy to our members.

MVEA, through partnerships with our wholesale power supplier, Tri-State Generation and Transmission Association (Tri-State), and the Colorado Clean Energy Fund (CCEF), is offering an on-bill repayment (OBR) program to members to install certain energy efficient upgrades to their property at no upfront cost. The OBR program allows members to make these upgrades and pay them off over time on their MVEA bill, breaking down barriers to accessing energy efficiency and electrification benefits. Below are some OBR program highlights that describe the benefits available to MVEA's membership.

#### No Money Down & No Credit Check

Instead of getting a loan through your bank or putting the expense on your credit card, payments are added to your monthly electric bill and can be repaid over one to 10 years, with interest rates between 4% and 4.99%. Since there's no loan through a bank or a credit card charge, your home upgrades won't affect your credit score or appear on your credit report.

#### Save On High Efficiency Upgrades

Make your home more comfortable while reducing your long-term energy bills. Upgrades include new insulation, windows and doors, water heaters, electric HVAC systems, electric vehicle chargers, and more.

#### Free Home Energy Assessments

Work with a Zero Homes assessor either virtually or in person to evaluate your home's energy use and identify areas where energysaving improvements can be made. Through data driven assessments the assessor can identify what measures will have the most impact—from insulation to windows to HVAC.

**Vetted Contractors** To be included in the program, contractors must apply, be accepted, and receive training to join *CCEE's* authorized ORB contractor

and receive training to join CCEF's authorized OBR contractor network. The OBR program's vetted network of qualified contractors are knowledgeable of program requirements and can perform installations of qualifying upgrades.

Another benefit of MVEA's On-Bill Repayment program is that it is administered through Tri-State and CCEF at no cost to the cooperative. That means this program does not impact our rates or operating costs. Funding is made available through CCEF, which is funded by state and federal programs.

While there are eligibility requirements, they are not overly restrictive. You must be the owner of a property in MVEA's service territory with an active account number; have a payment history of 12 consecutive months with MVEA; and, have no late penalties for the previous 6 consecutive months (or agree to enroll in bill autopay). Additional provisions may apply, but the program's ultimate goal is to address gaps in loan availability or approval, so members can access the funding they need to make energy-saving improvements.

If you are in the market for new insulation, windows and doors, water heaters, HVAC systems, or similar qualifying energy-efficient products, I encourage you to take a look at this new program that helps offset the investment of energy saving upgrades. # October is National Cybersecurity Awareness Month Don't Take the Bait! Lookout for Phishing Emails

Phishing is one of the most common attack methods used by cybercriminals and the one we're all probably most familiar with. Fortunately, there are signs that can help you identify whether or not an email in your inbox is a scam.

### Asking for Personal Most reputable organizations will never email you asking for your address, phone number, or other personal data. Information Always hover over links with your mouse pointer to display the full URL. If Inconsistencies it leads somewhere that doesn't logically belong within the context of the in Links email, or generally looks nonsensical, don't click! Phishing emails often feature threatening language, such as "Payment **Unrealistic Threats &** overdue!" or "Your account has been compromised!" in order to generate a Sense of Urgency response from their targets. BULL A You're Asked to Whether it be overdue taxes or an upfront payment to cover expenses, any email that asks for money should immediately raise your suspicions. Send Money Poor Spelling & Most generic phishing attempts contain spelling and grammatical errors or feature awkward wording/phrasing. Grammar
