Canterbury was selected by the board after interviews with three Fremont County residents who applied for the position.

About the Election Process

Director terms on the SDCEA board are for three years, with elections held annually on a rotating basis for each seat. Board members are elected by SDCEA's membership, comprised of account holders in the cooperative. This democratic process ensures that all members have a voice in the direction of their electric cooperative. While board members are elected to represent specific geographical areas of the cooperative, they are elected to serve all members. Two board seats are designated as at large.

- Charlie Abel, rural Chaffee/Lake counties, Vice-Chair
- Blake Bennetts, town of Buena Vista, Secretary
- Jeff Fiedler, At Large, Treasurer

The board also includes directors Mark Boyle, Rural Chaffee/Lake County; Sandy Long, At Large; and now Rob Canterbury, Fremont County.

Starting January 1, 2025, the monthly charge for Residential Rate 1 customers — most SDCEA accounts —will increase by \$3.50.

The Service Availability Charge increase varies by rate class. To view the applicable updated rates for all other rate classes, as well as projected Service Availability Charge rate increases through 2027 (subject to review each year and not mandatory), please visit myelectric.coop/boardinfo/bylaws-rates-policies/.

The Service Availability Charge covers expenses related to:

- infrastructure maintenance and upgrades;
- operational costs including materials, taxes, and labor;
- consumer services, including outage response and system software;
- compliance with regulatory requirements.


ENERGY EFFICIENCY TIP OF THE MONTH

Vegetation Management Alert

Attention Custer County Verdemont Road Area Residents:

Sangre de Cristo Electric Association began vegetation management work in the Verdemont Road, Custer County area at the end of September.

Vegetation management work is important for many reasons including:

- Wildfire Prevention. Removing overgrown vegetation significantly reduces the risk of wildfires created by vegetation coming in to contact with energized electric line, sparking and starting a fire, making our communities safer.
- Improved Service. By minimizing potential hazards— such as outages from falling tree branches which snap lines or damage equipment we ensure more reliable electric service. This also allows improved access for our crews to repair any issues that may arise on the system, enhancing overall service reliability.

This critical initiative is part of our ongoing efforts to prevent wildfires and enhance the reliability of electric service throughout our service territory.

The project is expected to take several months, depending on weather conditions.

Residents may notice our crews working in the area during this period. Please be cautious and maintain a safe distance from the work zones. Your cooperation is vital for ensuring the safety of both our crews and the community.

Funding for vegetation management comes from revenue from SDCEA's Wildfire Mitigation rate rider, budgeted funds and a state grant. To find more information on our program, scan the QR codes with you smartphone camera.
